## The Genesis: Born into Shadow (2003 – Childhood)

Raphael Andrew Tumba Hokinsa Bokingi Brookminster—born Raphael **Andrew** Nicolas Kabwema Tumba Hokinsa, and simply referred to as **Raphael Tumba Bokingi Brookminster**—entered the world prematurely on November 3, 2003, in the Brussels region of Belgium, into a Congolese family.

From his earliest years, his **hypersensitive, deeply empathic, and spiritually gifted nature** unjustly made him the **scapegoat** within his nuclear home. The household was emotionally fractured and chaotic, held hostage by the psychological and emotional brutality of extended family members—aunts and uncles who relentlessly hammered, brutalized, and ostracized his parents. Raphael and his siblings became collateral victims of this constant systemic stress.

He grew up isolated and deeply unhappy, enveloped by an atmosphere of tension, anxiety, and a suffocating sense of sulfur.

## II. The Paracosm: A Haven of Light

It was in the vibrant universes of **Disney, Pixar, Amblin, Marvel, DreamWorks**, and the worlds of **DC Comics, Warner Bros, Paramount, and Universal** that Raphael found his escape. These weren't mere forms of entertainment; they were portals to a different life—one that was beautiful, luminous, peaceful, and regal. They were the absolute antithesis of the daily chaos and distress he endured.

*“Growing up, he retreated into his own world—these worlds became his **emotional nuclear family** in his own mind, a safe haven to escape the constant pain.”*

Within these imagined realms, he discovered a sense of peace, security, unconditional love, validation, and a profound feeling of being home. A connection to the imaginary, to art, was woven indelibly into the fabric of his soul.





### III. The Crucible of Isolation (High School & The "Friends")

At age 11, his family relocated, a move Raphael hoped would signal a fresh start. It did not. High school only amplified the suffering. He was immediately sidelined, never invited, and left to drift as a forgettable "friend." He was the one who was made to feel he didn't belong, the one who annoyed people simply by existing. He watched others form genuine, protective bonds, while he sat on the outside, consumed by a longing for that same connection.

When he tried to vocalize his feelings, he was met with insult and dismissal. Yet, when others voiced the same complaints, their emotions were instantly validated. This pattern persisted every day throughout high school. He was not admired like the **"golden boys"** whom everyone—even the teachers—seemed to adore. Most days, he ate lunch alone, escaping deeper into his **paracosm**, the imaginary world he built to drown out the deafening noise of his loneliness.

During this period, he endured a deeply traumatic and devastating experience: he was subjected to **psychological, emotional, and social abuse** over several years by a group of so-called "friends" who exploited his vulnerability, leaving him shattered. This external torment occurred simultaneously with the chaos he continued to suffer at home. When he finally found the courage to speak out, he was met with disbelief. People sided with his abusers because they were popular, handsome, wealthy, and well-liked. He was just the weird, broken, poor kid who didn't matter. The insults piled up: "weird," "crazy," "sick." He pushed so hard to connect, to be seen, to be included, but it never worked. He was **invisible. Forgotten.**

The pain became unbearable. He began **self-harming** and attempted suicide multiple times. The crushing loneliness, rejection, and isolation were relentless. Even online, he was forgotten—if he didn't reach out first, no one, ever, messaged him.





## IV. The Betrayal: The P-RICO Extended Family

He hoped his extended family would be different, that his cousins would offer respite. He was wrong.

One cousin pretended to be a close confidant, but secretly manipulated him and used him for entertainment. Eventually, the cousins ganged up on him, ghosted him, and successfully painted him as the villain—the crazy, sick, evil one.

When the cousin "**Cousin B**", who had initiated a "**Quasi-Fusion**" relationship—defining their bond as an indissoluble "**pack**" and "**family**"—betrayed him, responding to his distress with aggression and insults, the extended family provided full, devastating support. Uncles and aunts **sided with Cousin B**, insulting Raphael and even congratulating the aggressor on his actions. While the adults had systematically engaged in psychological violence for years, the cousins intensified the brutality from **2022 to this day (2025)**, the year **Cousin B** deliberately betrayed Raphael and all the boys united to destroy Raphael and support each other. When Raphael's pain culminated in a **suicide attempt** caused by the collective cruelty of **Cousin B** and the family's endorsement, they expressed utter indifference. Instead of concern, they chose silence, self-protection, and mutual congratulations, passing the incident off as inconsequential to shield their own.

His life has been a state of **carnage, havoc, and total wreck** in every sense of the word. Everything was ravaged: no family, no friends, no joy, no peace. The price that gave his executioners peace fell entirely upon him. He was their scapegoat, their **Isaiah 53**. He was allowed nothing, held guilty for the punishments they inflicted, and reduced to emotional captivity and silence.

While his peers at school were allowed to form friendships, spend time together, and create memories, his school even attempted to unjustly send him to a psychiatric hospital, siding with his bullies. This period of intense external and familial psychological warfare lasted for **8 years**, out of **21 years** of his life.





## V. The Birth of a Dynasty and Global Reach

Despite being rejected, alone, misunderstood, and mocked for two decades, Raphael **never gave up**. Working literally every day from the age of 14, in parallel with his isolation, he relentlessly developed his company.

On February 24, 2025, at just **21 years old**, and remotely from Belgium, he successfully launched his **LLC in Florida**. He achieved this without money, without a powerful family name, alone, and without any support, all while being continuously criticized.

His resilience is further demonstrated by the **top-tier, elite LinkedIn network** he cultivated between April 2025 and November 2025—all while being only 21, never having left Belgium, and operating solely from his room in his parents' house, without funding or social backing. The following list represents the **complete and detailed extraction** of this powerful LinkedIn network:

Not only did he launch the LLC and **connect** with these professionals on LinkedIn, but still in 2025—just one month after his 22nd birthday and without external funding, support, degrees, or fortune—he established a publishing division of that same LLC, successfully selling books **translated into 35 languages** across **major global platforms** including Google Play Books,



KDP, Kobo, B&N, Apple Books (for eBooks), and IngramSpark (for print books).

In 2023, at the age of 20, he founded his own Family House, his own Dynasty: **“The House of Tumba-Bokingi Brookminster.”** This act served as a definitive and intentional severance from the extended family members who bear **the same family name as him** and were the oppressors responsible for the P-RICO structure that tormented his household for 21 years.

This is not a tale of revenge, but an act of profound self-reclamation. With this new Dynasty, Raphael establishes a **new history, a new lineage, and a new direction** for his life and legacy.
